Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued as G.O.(Ms.)No.114/2022/Home dated 10th June, 2022, the Government had accorded Administrative Sanction for the establishment of an Additional District and Sessions Court (Special Court) for the trial of Puttingal Devi Temple Fireworks Mishap Case.
