Speech by Sri. K. Gopalakrishna Kurup, Advocate General.

Ladies and Gentlemen;

We all have assembled here today to bid a respectful and solemn farewell to Hon'ble Mr. Justice Amit Rawal, a scholarly jurist par excellence, who is hanging his robes as a Judge of this Honourable Court on 21stday of September, 2025, upon attaining the age of superannuation.

My Lord was born on 21stSeptember, 1963, at Chandigarh, to Dr. Om Prakash Rawal and (Late) Smt. Tripta Rawal. After completing schooling at Government Senior Model School, Chandigarh and graduating from DAV College, Chandigarh, you pursued law at Panjab University, successfully completing the degree in law in 1986.

On 7thSeptember, 1986, My Lord enrolled as an Advocate with the Bar Council of Punjab and Haryana. In the course of practice, you handled a wide spectrum of cases ranging from civil disputes and matrimonial causes to company law issues as well as constitutional matters. This diversity of work contributed immensely to your depth of knowledge and versatility in law. Your clientele included the Bar Council of Punjab and Haryana. You served with distinction as Additional Advocate General, Punjab.

In recognition of your professional eminence, My Lord was designated as a Senior Advocate by the Punjab and Haryana High Court inMay, 2012. The Chandigarh Tribune, while commenting on the then list of senior designations, made a special mention of you, indicating your distinct journey as one who chartered an independent path in law, though hailing from a family of doctors. So said Chandigarh Tribune dated 10th of May, 2012 about you: "Amit Rawal is the only black coat among whites. Belonging to the family of doctors, he did his law from Panjab University in 1986 and has been dealing with civil, rent and corporate matters."

On 25th September, 2014, My Lord was elevated as an Additional Judge of the Punjab and Haryana High Court, and was appointed as a Permanent Judge on 23rdMay, 2016. During your tenure as a Judge of the Punjab and Haryana High Court, you displayed remarkable industry, disposing of nearly 17,965 cases as a Single Judge and contributing to the disposal of 1,658 matters in Division Benches. You rendered notable judgments in multifarious cases arising out of diverse subjects likeConstitutional Law, Land Laws, Commissions of Inquiry Act, 1952, Companies Act, 2013, Arbitration and Conciliation Act, 1996, Insolvencies and Bankruptcy Code, 2016, Benami Transactions (Prohibition) Act, 1998, Hindu Marriage Act, 1955, Civil Procedure Code, 1908, SARFAESI Act, Motor Vehicles Act, 1988etc, deciding hundreds of hitherto undecided legal principles. Your tenure at Punjab and Haryana High Court also saw you rendering valuable service as a member of important Committees therein, including the Rules Committee under the Code of Civil Procedure, the Protocol Committee, the Arbitration Committee under the Chandigarh Arbitration Centre Rules, the Service Appeal Committee, and the Building Committee.

Upon transfer to the High Court of Kerala, My Lord was sworn in on 12thNovember, 2019. You were the fourth Judge from Punjab and Haryana High Court to adorn the Bench of this Hon'ble Court, the earlier three being Justice Jawaharlal Gupta, Justice Nauvdip Kumar Sodhi and Justice Vinod Kumar Bali, all of whom were Chief Justices of this Hon'ble Court.

In this Hon'ble Court also, your hallmark of diligence continued unabated, with disposal of nearly 12,500 cases. You thus stand as a shining example of efficiency, dedication, and unwavering commitment to the dispensation of justice.

I have had opportunities to appear before My Lord in this Court in very many matters. These were occasions wherein I could witness first-hand your flashes of brilliants and the panache with which you handled basic legalprinciples and tenets of constitution law.

My Lord's judicial life has been guided not only by your love for law, but also by a sense of higher duty to society. An illustration of this is your inspiring address on the International Day for the Girl Child in 2015, wherein it was emphasised that empowerment of young girls was central to the progress of the nation. You concluded quoting the following words of Napoleon Bonaparte: "Give me good mothers, and I shall give you a great nation." Such reflections demonstrate a vision that transcends the law, rooted in social justice and equality.

My Lord's interests beyond the law are equally noteworthy. Fond of cricket, you have taken the field in several friendly matches among Judges and in veteran tournaments. Equally keen on golf, you have actively participated in league and alumni tournaments at Chandigarh, and even presided over the conduct of an All India Golf Tournament at Kochi in 2024. You are also a gifted singer. These pursuits reflect a wholesome personality that blends the rigour of judicial duty with the grace of sportsmanship and artistic talent.

My Lord is blessed with a devoted family. Your wife, Smt. Meenakshy Rawal, is a practising psychological counsellor. The family is further adorned by a son, Shri. Tushan Rawal, Advocate at Delhi, and a daughter, Ms. Tanvi Rawal, Creative Director and Stylist at Delhi, both of whom excelling in their respective spheres.

My Lord, the true measure of a judge's career is the dignity with which they depart the bench. You have done so, leaving behind a legacy that will endure. Your judicial journey has been a masterclass in erudition and tireless devotion to duty.

It's time to say goodbye, but I think goodbyes are sad, and I'd much rather say hello; hello to a new venture. My Lord, your undying passion for the law is well known and true to this commitment, even after demitting judicial office, you intend to remain associated with the law by resuming practice before the Supreme Court of India. As you lay down the robes of judicial office and resumes practice, I, on behalf of the entire Bar of Kerala, extend heartfelt felicitations and warmest wishes. On behalf of all present, I convey our profound gratitude for My Lord's distinguished service to the cause of justice. May your future be blessed with good health, happiness, and continued accomplishments.

Today as we gather to bid farewell to Justice Amit Rawal on his retirement from the Kerala High Court, we acknowledge his distinguished career and invaluable contributions to the Indian judiciary. We reflect on a journey marked by dedication, judicial courage, and unwavering commitment to justice.

Born on September 21, 1963, he graduated from DAV College, Chandigarh, in 1983. He obtained his law degree from Punjab University, Chandigarh and enrolled as a member of the Bar Council of Punjab and Haryana in 1986.

Justice Rawal began his professional journey representing the Bar Council of Punjab and Haryana in the High Court and other institutions, quickly establishing himself as a formidable legal mind. His legal scholarship spans diverse areas of law, demonstrating remarkable versatility and deep understanding of complex legal principles. His expertise and dedication to law were

formally recognized when he was designated as Senior Advocate on May 8, 2012 - a testament to his exceptional skills and contributions to the legal profession. Justice Rawal was appointed as an additional Judge of the Punjab and Haryana High Court on 25-09-2014 and served there until his transfer to the Kerala High Court in November, 2019. This transfer brought fresh perspectives and enriched the judicial discourse in Kerala.

Justice Rawal's judicial tenure has been marked by several significant judgments that have contributed meaningfully to Indian jurispruden ce. The defining element of Justice Rawal's tenure was the Judicial courage he demonstrated consistently.

One of Justice Rawal's most impactful contributions lies in the area of motor vehicle accident compensation. He delivered a landmark judgment that fundamentally changed how medical expenses are assessed under Section 163A of the Motor Vehicles Act. Justice Rawal courageously deviated from the statutory formula and eloquently stated: "Judiciary cannot be a partner in slumber of the legislature," establishing a precedent that courts must ensure just compensation despite legislative inaction.

During his tenure at the Kerala High Court, Justice Rawal has presided over numerous cases with wisdom, fairness, and judicial temperance. His approach to justice has been characterized by meticulous attention to detail, deep legal scholarship, and a commitment to upholding the rule of law. Justice Rawal's tenure at the Kerala High Court has been equally distinguished, marked by several landmark judgments that have addressed contemporary

legal challenges with wisdom and judicial courage.

Justice Rawal, heading a Division Bench, handled one of the most sensitive and tragic cases involving the death of student Sidharthan due to alleged ragging. The Division Bench upheld the university's decision to expel and debar the students involved, finding it proper and proportionate to the gravity of the offence. Justice Rawal's approach balanced the need for justice for the deceased student's family while ensuring procedural fairness for the accused.

Justice Rawal with his boldness and Judicial courage granted relief to hundreds of innocent depositors who invested their life savings in Cooperative Societies operating rampantly in Kerala as 'banks'. He ensured many of the victims got atleast a part of the monies invested and brought the perpetrators to Justice. Justice Rawal delivered a comprehensive judgment on the constitutional validity of term restrictions for cooperative society committee members. His judgment demonstrated deep constitutional analysis, holding that "the right to contest an election is a statutory right and not a common law right" and that such restrictions serve public interest by preventing vested interests and misappropriation in societies handling public deposits. He also addressed surcharge orders under the Kerala Local Fund Audit Act, establishing important precedents for financial accountability in local governance. His cooperative society judgment reflects deep concern for institutional integrity and public trust, recognizing that financial institutions handling public deposits require higher standards of governance.

Whether dealing with student safety versus educational rights, or institutional autonomy versus

regulatory oversight, Justice Rawal has demonstrated remarkable ability to balance competing legitimate interests while upholding the rule of law. Justice Rawal believed that law must evolve to meet contemporary social needs and has consistently chosen substance over form, justice over technicality. Throughout his career, Justice Rawal has shown that law must serve human dignity and welfare.

Justice Rawal's judgments consistently reflect three key characteristics: meticulous legal research, compassionate understand ing of human circumstances, and unwavering commitment to justice over rigid procedural compliance.

Justice Rawal's career spans decades of dedicated service, first as a practicing advocate and later as a distinguished member of the judiciary. His journey from a young law graduate in Chandigarh to a respected High Court Judge represents not just personal achievement, but also embodies the ideals of hard work, continuous learning, and steadfast commitment to justice.

On behalf of the entire legal community, the Kerala High Court Advocates Association extend our heartfelt gratitude to Justice Rawal for his years of dedicated service. As you embark on this new chapter in your life, we wish you good health, happiness, and fulfilment.

The gratitude of the Bar will be incomplete if we forget to thank Mrs. Meenakshi

Rawal who have been with you throughout your Journey. Thank you mam for your sacrifices that enabled him and empowered him to discharge his duties.

Justice Rawal was born on 21st September 1963 at Chandigarh. He received his schooling from Government Senior Model School, Chandigarh and completed his graduation from DAV College, Chandigarh in the year 1983. He obtained his degree in Law from the Punjab University in 1986. Thereafter, he enrolled as an Advocate with the Bar Council of Punjab and Haryana on 7th September, 1986.

Justice Rawal was the first in his family to enter the legal profession and with hard work established himself as a distinguished legal professional. Over the course of his career, as an Advocate he appeared in cases in various fields including civil law, property law, matrimonial law, company law, rent control and various other jurisdictions involving intricate questions of law.

As an Advocate, Justice Rawal represented the Bar Council of Punjab and Haryana, as well as several other esteemed institutions in the High Court of Punjab and Haryana. Justice Rawal was designated as a Senior Advocate on 8 May, 2012.

Justice Rawal also served as the Additional Advocate General for the State of Punjab.

In recognition of his legal acumen and dedication to the profession, Justice Rawal was elevated as an Additional Judge of the Punjab and Haryana High Court on 25th September 2014.

He was later confirmed as a Permanent Judge on 23rd May 2016.

Justice Rawal assumed charge as a Judge of the Kerala High Court on 12 November 2019.

In this Court, Justice Rawal dealt with cases in various jurisdictions, including Writ petitions, Writ appeals, Land acquisition appeals, Matrimonial appeals etc.

His Judgements are progressive and had a far reaching impact, such as the one deciding the constitutional validity of term limitation of credit Societies and the interpretation of High Tide Line and the Coastal Regulation Zones in Kerala.

On the Administrative side of the High Court, Justice Rawal contributed as the Chairman and member of several committees. More particularly the Administrative Committee, Library Committee and Committee to periodically oversee the progress of the cases under special Acts. Justice Rawal was also on the Board of Governors, of the Kerala State Mediation and Conciliation Centre.

Justice Rawal is a keen sportsman with a passion for Golf and Cricket. Justice Rawal's contribution to this court on the judicial as well as administrative side will always be valued.

It must be mentioned that his contribution to this Institution was possible with the steadfast support of his family. Acknowledgements and gratitude are due to his wife, Mrs. Meenakshy Rawal, daughter Tanwi Rawal and son Tushan Rawal for their valuable support in enabling Justice Rawal to discharge his duties as a Judge of this Court.

Brother Justice Rawal is now set to embark on the next stage of his journey. On behalf of my sister and brother Judges and on my behalf, I wish him good luck for his future endeavours and the very best in life.

As a guardian of justice, I am reminded that 'Justice is not a mere abstract concept, but a living, breathing reality that must be accessible to all, without distinction or discrimination.' I hope that every judgment i delivered reflected the unwavering commitment to equality, as enshrined in our Constitution. Ultimately, the true measure of a judiciary lies in the confidence it inspires among the people it serves. While I cannot say if I have fully succeeded in this endeavour—that is not for me to judge—I have found deep fulfillment in doing my utmost to serve justice faithfully and conscientiously. If, at any point while discharging the justice, my decisions or actions have caused unintended hardship or distress, I humbly ask for your understanding and forgiveness. My guiding principle has always been a sincere dedication to justice and an honest conscience.

To my family — words will never suffice. I hold with profound gratitude the unwavering and relentless support and love of my family, without whom this journey

would not have been possible.

My beloved parents, Sri. Om Prakash Rawal and Late.Smt.Tripti Rawal, my journey would have been impossible without the unwavering love and support of my parents, who stood by me through every triumph and trial. Though my dear mother is no longer with us, I feel her providence, which inspires me every day. Bringing my father to Kerala in his old age and seeing the pride and joy in his eyes has been one of my greatest blessings — a moment that fills my heart with profound gratitude and love. I am also deeply thankful to my in-laws, whose faith in me and steadfast support have been my anchor in life's most challenging moments. Their belief gave me strength when I needed it most, and for that, I am eternally grateful.

My dear wife, Mrs. Meenakshi Rawal, a psychologist and counsellor by profession, have been my steadfast rock and pillar of strength, especially in moments of uncertainty and transition particularly when I was transferred to Kerala, away from the familiar comforts of home. You managed to balance your professional and personal life, responsibilities with grace, without ever adding to my pressure, making everything easier for me, by lovingly taking care of my father and children, even during my absence across the miles.
