— Section 13 (7)—Kerala University of Digital Sciences, Innovation and Technology Act, 2021—Section 11(10) (Kerala Act 10 of 2021)— Appointments of temporary Vice- chancellors can be only for a specified period, not exceeding six months in aggregate - Such appointments must be done on recommendations of the Government - Chancellor, Kerala University of Digital Sciences Innovation and Technology v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Order XXII Rule

10A—A lawyer, on coming to know of the death of a party represented by him, is obliged to inform the court and the opposite party of such death—This duty is not discharged by merely intimating the factum of death; The pleader must also furnish particulars of the persons on whom and against whom the right to sue survives—Failure to fulfil this statutory duty disentitles the defaulting party from

pleading abatement, as no one can be permitted to take advantage of their own wrong—nullus commodum capere potest de injuria sua propria— Legal Maxim - Binod Pathak and others v. Shankar Choudhary and others - I.L.R. 2025 Kerala OnLine 276 : [Neutral Citation No. 2025 INSC 842](#).

Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Section 311—Recall and further cross-examination of victim in rape and POCSO case—Further examination of the victim on the ground of compromise cannot be allowed in cases where the offence alleged is under Section 376, IPC—Attempt to recall victim to retract earlier testimony amounts to subverting judicial process - Shiju Krishnan v. State of Kerala - I.L.R. 2025 Kerala OnLine 277 : [Neutral Citation No. 2025:KER:55609](#).

Constitution of India—Article 226—Certiorari—Writ of Certiorari would lie against an order passed by the judicial / quasi-judicial authority or executive authority only if the order passed by the executive authority has trapping of quasi-judicial order—Administrative order ‘per se’ cannot be set aside by a Writ of Certiorari - Ajeesh Mathew (Dr.) v. State of Kerala and others - I.L.R. 2025 Kerala OnLine 275: [Neutral Citation No. 2024:KER:96571](#).

UGC Regulation, 2018—Clause 7.3—Principle of repugnancy— Temporary appointments are not governed by clause 7.3 or 7.3.0 of the UGC regulations and hence, there is no repugnancy—Constitution of India—Article 254 - Chancellor, Kerala University of Digital Sciences Innovation and Technology v.
