Arbitration and Conciliation Act, 1996 (Central Act 26 of 1996)—Sections 2 (1) (h) and 34 (3)—‘Party’—‘Party making that application had received the Arbitral award’—In order to constitute an effective service, a copy of an award, where such party is the Ministry of a particular Department, is to be delivered to a person who has the knowledge and is the best person to understand and appreciate an award and more particularly, to take decision for its challenge—Service of award on the Authorised representative of the State is not effective service as he is not competent to take a decision on whether to challenge the award or not - Motilal Agarwala v. Citizenship Act, 1955 (Central Act 57 of 1955)—Sections 5(1)(d) and (f)—Grant of Indian citizenship—Indian law does not permit dual citizenship—Formal renunciation of foreign citizenship is mandatory—No exceptions based on age or circumstances—For recognition as an Indian citizen, the individual must be acknowledged solely by the Indian State, free from competing claims of another country—Formal renunciation of Pakistani nationality by way of Renunciation Certificate is a mandatory requirement— Mere surrender of passport or issuance of “No Objection Certificate” by Pakistan High Commission does not amount to renunciation—Pakistan Citizenship Act, 1951—S.14A - Union of India v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 80—Issuance of notice— Mandatory—Service of notice under Section 80 CPC is a condition precedent for institution of a suit against the Government or a public officer—Non-compliance renders the suit not maintainable, except where urgent and immediate relief is sought and prior leave of the court is obtained under Section 80 (2) - Government College, Chavara and another v. Ambikadevi Amma E. and others - I.L.R. 2025 Kerala OnLine 299 : [Neutral Citation No.2025:KER:64138](#).

Constitution of India—Article 226—Emergency leave cannot be granted unless there exists some extra-ordinary situation—Emergency leave cannot be granted to take care of pregnant wife—Kerala Prisons and Correctional Services (Management) Rules, 2014— Rule 400 - Bindhu K.P. v. State of Kerala and others - I.L.R. 2025 Kerala OnLine 302 : [Neutral Citation No. 2025:KER:59006](#).

Constitution of India—Article 226—Scheme of the Act examined—Guidelines and directions issued to constitute Kochi Metropolitan Transport Authority—Kerala Metropolitan Transport Authority Act, 2019 (Central Act 25 of 2019) - Richard Rajesh Kumar (Adv.) and another v. Contract Act, 1872 (Central Act 9 of 1872)—Section 72—Unjust Enrichment—To invoke Section 72, the plaintiff must specifically plead and prove the ingredients of Section 72 and also establish that restitution will not result in unjust enrichment—Mere financial difficulty or bargaining in the course of a creditor–debtor relationship does not amount to “coercion”—For the purposes of Section 72, coercion is not confined to the definition in Section 15 of the Act but is to be understood in the wider sense of payment under compulsion - Dhanlaxmi Bank Ltd. v. M/s. Ananth Oil Extractions Ltd. - I.L.R. 2025 Kerala OnLine 305 : [Neutral Citation No. 2025:KER:62522](#).

Easements—Effect of acquisition—In its widest sense, “encumbrances” necessarily include easementary rights such as right of way—Once acquisition takes place, any existing easementary right, if any, stands extinguished, and therefore no claim for easement will lie against the State—Section 16—Land Acquisition Act, 1894 (Central Act 1 of 1894) - Government College, Chavara and another v. Ambikadevi Amma E. and others - I.L.R. 2025 Kerala OnLine 299 : [Neutral Citation No.2025:KER:64138](#).

Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Sections 50 & 51—The owner is liable to pay the tax till the date on which possession was taken by the financier - Rubeesh Shamsudheen v. Joint Regional Transport Officer and others - I.L.R. 2025 Kerala OnLine 298 : [Neutral Citation No. 2025:KER:37849](#).

Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Section 9—The transferee of a motor vehicle is liable to pay the tax that remained unpaid at the time of transfer - Rubeesh Shamsudheen v. Joint Regional Transport Officer and others - I.L.R. 2025 Kerala OnLine 298 : [Neutral Citation No. 2025:KER:37849](#).

Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Sections 3 and 5—The liability to pay tax is upon the person who is in actual possession and control of the motor vehicle—Such possession should be of a substantive nature - Rubeesh Shamsudheen v. Negotiable Instruments Act, 1881 (Central Act 26 of 1881)—Section 138—Sections 118 and 139—The standard of proof to rebut the statutory presumption is preponderance of probability—This can be inferred from materials on record and circumstantial evidence - Varghese K.P. v. Elias I.M and another - I.L.R. 2025 Kerala OnLine 301 : [Neutral Citation No. 2025:KER:62745](#).
