Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)—Section 483—Court deprecated the practise of filing simultaneous bail applications before Special Court and High Court, in an experimental manner—Registry is directed to verify all bail applications filed before High Court to ensure that an undertaking is filed in all the bail applications, stating that "no other bail application/applications filed or pending in any other Courts in the District Judiciary as on the date of filing of the bail application before this Court"—Accused was granted bail after taking note of the was in custody, and investigation has progresse—Bharatiya Nyaya Sanhita, 2023 (Central Act 45 of 2023) —Section 61—Prevention of Corruption Act, 1988 (Central Act 49 of 1988)—Section 7(a) -Lalachan V.M. v. Constitution of India—Part III—Fundamental Rights—Prisoners' Rights—A prisoner does not forfeit his fundamental rights upon conviction; Such rights are restricted only to the extent that their exercise becomes impossible as an incident of conviction and confinement—The Kerala Prisons and Correctional Services (Management) Act, 2010 and the Rules contain no provision authorising the prison authorities or the Government to prohibit a prisoner from publishing his literary work—The Kerala Prisons and Correctional Services (Management) Act, 2010 (Kerala Act 9 of 2010) - Roopesh T.R. v. Consumer Protection Act, 2019 (Central Act 35 of 2019)—Sections 2(7) and 2(42)—When the expression 'service', is specifically defined under the statute, by including the facilities in connection with Banking and Financing, the same has to be given effect to, by extending a wider meaning possible, so as to include all possible transactions forming part of the instances referred to in the said provision—When an individual is making investments in his individual capacity for better profits to make his life better, under no circumstances, that could be treated as a commercial purpose - Mathew K. Cherian v. State Consumer Disputes Redressal Commission and another - I.L.R. 2025 Kerala OnLine 355: Neutral Citation No. 2025:KER:80559.

Forest Act, 1961 (Kerala Act 4 of 1962)—Section 53—Section 53 empowers the competent officer to grant interim custody of the vehicle seized for transporting river sand from the forest, on the owner executing a bond - Insisting on Bank guarantee for release of vehicle is an onerous condition - Shijo Mon Joseph v. **Guruvayur Devaswom Act, 1978 (Kerala Act 14 of 1978)**—Section 10—Duty of Managing Committee of Devaswom Board—Directions issued to ease the difficulties faced by devotees in Lord Krishna Temple, Guruvayur - Radhakrishnan P.N. v. State of Kerala and others - I.L.R. 2025 Kerala OnLine 358: Neutral Citation No. 2025:KER:89186.

Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957)—Section 21(4)—Hallmark of the expression 'transport' is the act of carrying a thing from one place to another—When it is understood in the context of Section 21(4), the term 'transport' connotes carrying mineral from one place to another—Actual movement of the vehicle is a not sine qua non to constitute 'transport'—Process of transport or transportation commences with the loading of the mineral into the vehicle, in order to carry it from one place to another - Pranav Mohanan v. District Geologist and another - I.L.R. 2025 Kerala OnLine 361: Neutral Citation No. 2025:KER:88205.

Minimum Wages Act, 1948 (Central Act 11 of 1948)—Sections 2(e) and 20(3)—Managing Director of the company is a statutorily recognized person to be treated as the "employer" as defined under Section 2(e) of the Minimum Wages Act—The order passed by the statutory authority under Section 20(3) of the Minimum Wages Act is binding on the Managing Director, in the capacity as 'employer' - Bhavesh Anil Kumar v. Assistant Labour Officer (Grade II) and another - I.L.R. 2025 Kerala OnLine 363: Neutral Citation No. 2025:KER:81754.

**Muslim Personal Law**—On divorce, a Muslim husband must make a reasonable and fair provision for the wife's future maintenance, enabling her to sustain herself until remarriage—The amount is fixed with regard to the parties' status, age, standard of life, prospects of remarriage, duration of cohabitation, financial circumstances, and other relevant factors, and must be sufficient to meet her future needs in the prevailing socio-economic conditions — Kannadan Anwar Salih v. Safeekhath and another - I.L.R. 2025 Kerala OnLine 359: Neutral Citation No. 2025:KER:78554.

Muslim Women (Protection of Rights on Divorce) Act, 1986 (Central Act 25 of 1986)—Section 3—The Act does not override or extinguish a divorced Muslim woman's right to maintenance under Section 125 Cr.P.C.—She remains entitled to maintenance under S.125 Cr.P.C. until she remarries or the amount payable under S.3 is actually paid—Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Section 125 - Kannadan Anwar Salih v. Safeekhath and another - I.L.R. 2025 Kerala OnLine 359: Neutral Citation No. 2025:KER:78554.

Penal Code, 1860 (Central Act 45 of 1860)—Sections 90, 376, 493 and 496—Long-term consensual sexual relationship on promise of marriage does not constitute rape unless intention to deceive exists from inception—Sexual relationship maintained for years even during subsistence of complainant's prior marriage indicates consent—A promise to marry without anything more will not give rise to misconception of fact within the meaning of Section 90 IPC—Absence of consent cannot be presumed in every case where the prosecutrix alleges that she indulged in sexual intercourse with the offender believing the offer of marriage made by him—For bringing home the offence of rape, it has to be established that from the very beginning the accused was not having any intention at all to marry the prosecutrix and that the offer of marriage was made as a ploy to make her surrender to him in order to satiate his carnal desires—Offences under Sections 493 and 496, IPC cannot be prosecuted on a police report in view of Section 198, Cr. PC—Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Sections 198 and 482 - Pradeep v. Station House Officer - I.L.R. 2025 Kerala OnLine 360: Neutral Citation No. 2025:KER:87073.

Real Estate (Regulation and Development) Act, 2016 (Kerala Act 5 of 2016) —Section 3—Prior registration of real estate project with Real Estate Regulatory Authority—Execution of a registered sale deed after coming into the force of the Act namely 01.05.2017 by itself is sufficient to attract the charging provision - Bharathan K. and another v. Top Crystal Owners Association and others - I.L.R. 2025 Kerala OnLine 364: Neutral Citation No. 2025:KER:81394.

Specific Relief Act, 1963 (Central Act 47 of 1963)—Section 12(2)—Specific performance of part of a contract—A decree for partial specific performance can be granted only when the promisor is genuinely unable to perform the whole of the contract—Specific performance cannot be confined to a lesser extent when the defendants have full title and possession over the entire property agreed to be sold, as such circumstances do not constitute any "inability to perform." - Vasudevan Nair T.K. and others v. Vrij Mohan T. and others - I.L.R. 2025 Kerala OnLine 356: Neutral Citation 2025:KER:83970.
