**Admiralty (Jurisdiction and Settlement of Maritime Claims), 2017 (Central Act 22 of 2017)**— Sections 4 and 6—A Suit cannot be continued against the employees of the Vessel without any claim against the Vessel or its owner – Only if the Vessel or its owner is a party, a Suit can be filed under the Admiralty Act in respect of a maritime claim—Such suits cannot be maintained only against the employees in a Vessel - Master of the Vessel M.V. Korea Chemi (IMO 9274276) v. Silavuvaipichai Francies and others - I.L.R. 2026 Kerala OnLine 61.

**Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)**—Section 47—The grounds of arrest shall be communicated to the arrested person in every case, without exception, and such communication shall be made in writing in a language understood by him—In prosecutions under the NDPS Act, the requirement to communicate the quantity of contraband seized cannot be construed as applying uniformly to all accused, irrespective of their alleged role or complicity—The obligation to specify the quantity of contraband arises only in respect of those accused from whose possession the contraband was actually seized —Article 22(1)— Constitution of India - Imran @ Hamsath Ikthiyar @ Irshad v. **Code of Criminal Procedure, 1973 (Central Act 2 of 1974)**—Section 313 —False or unsatisfactory explanation—In a case based on circumstantial evidence, a false or

unsatisfactory explanation offered by the accused under Section 313 cannot by itself constitute an independent link in the chain of circumstances; however, such explanation can be taken into account to fortify or lend assurance to the conclusion of guilt otherwise established by the prosecution - Nitheesh v. **Comprehensive Leave Rules for NBEMS trainees, 2024**—Clause 7 (c)—Maternity leave and other leave—Maternity leave is a right of the women—Maternity leave cannot be counted for calculating the total leave to apply the principle of ‘no leave beyond one year’ - Susan K. **Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)**—Sections 80, 80BB and 109— Dairy/Milk Co-operative stand on a different footing and there is intelligible differentia in introducing Section 80BB, by which an obligation is cast on the Government to constitute Recruitment Committee for the entire selection and recruitment process of all permanent employees of the Regional Co-operative Milk Producer’s Unions—When the provision does not mandate publication in Official Gazette, the impugned orders cannot be declared illegal on the ground of non-publication in Official Gazette—Constitution of Recruitment Committee for making appointments to the Regional Milk Producer’s Unions is not primarily intended for fixing or altering the number and designation of the officers and servants of those Unions—Co- operative Societies Rules, 1969 (Kerala)—Rule 182 - Kanichiodu MPCOS Ltd 181(D) APCOS and others v. **Hindu Adoptions and Maintenance Act, 1956 (Central Act 78 of 1956)**—Section 28—Attached property alienated by husband before attachment by wife in a petition for maintenance—Claim petition by purchaser dismissed—Appeal by purchaser allowed and case remanded—Wife granted an opportunity to prove that the purchaser was aware of denial of maintenance by the seller to his wife and any subsisting claim for maintenance which arose out of such denial, or that there were reasons to show that the transfer was gratuitous—Transfer of Property Act, 1882 (Central Act 4 of 1882)—Section 39 - Sulochana v. **Industrial Disputes Act, 1947 (Central Act 14 of 1947)**—Section 10— Function of the appropriate Government in making a reference is purely administrative in character—It is nevertheless incumbent that the reference correctly encapsulates the real and foundational controversy between the parties—Once a reference is made, the jurisdiction of the Labour Court or Industrial Tribunal is strictly confined to the

points of dispute specifically referred and matters incidental thereto, and the Tribunal is not free to enlarge, amend, substitute, or re-characterise the dispute on its own assessment of the pleadings or evidence— Adjudication made by the Labour Court beyond the reference is coram non iudice—Award passed pursuant to a defective and jurisdictionally infirm reference is a nullity, being one rendered without authority of law - Lunar Rubbers v. **Industrial Disputes Act, 1947 (Central Act 14 of 1947)**—Section 25FFF— Once the factum of closure of an undertaking, or of a unit lacking functional integrality with other units, is admitted or established, the employer-employee relationship comes to an end by operation of law - Lunar Rubbers v. Kerala Head Load and Timber Workers and Factory Workers Union (KTUC) and others - I.L.R. 2026 Kerala OnLine 62 : [Neutral Citation No. 2026:KER:7635](#).

**Penal Code, 1860 (Central Act 45 of 1860)**—Section 302—Conviction based on circumstantial evidence—Principles governing appreciation— Where the prosecution case rests entirely on circumstantial evidence, the circumstances relied on must be cogently and firmly established; such circumstances must be of a definite tendency unerringly pointing towards the guilt of the accused; the cumulative effect of the proved circumstances must form a complete chain leaving no reasonable ground for a conclusion consistent with the innocence of the accused; and the evidence must be incapable of explanation on any hypothesis other than that of guilt—The circumstances must not only be consistent with the guilt of the accused but must also be inconsistent with his innocence—In a case resting on circumstantial evidence, proof of motive constitutes an important link in the chain of circumstances, though its absence is not by itself fatal to the prosecution; motive assumes greater significance where there is no direct evidence, but recedes in importance when there is clear ocular testimony implicating the accused - Nitheesh v. **Penal Code, 1860 (Central Act 45 of 1860)**—Section 302—It is trite that primary object of an FI Statement or FI Report is only to set the criminal law in motion and it would be unreasonable to expect a FI Statement to contain every minute detail pertaining to an incident with unerring precision—Statement made by the deceased in the moments before he succumbed to those injuries would effectively constitute a dying declaration – Doctrine of ‘res gestae’ explained— Evidence Act, 1872 (Central Act 1 of 1872)—Sections 6 and 32 - Chathu @ Alakkadan Chathu v. **Service Rules, 1959 (Kerala)**—Part-III, Rule 3, Ruling No. 1—Recovery from DCRG—Necessity of obtaining undertaking at the time of retirement, permitting

recovery from DCRG—Provisions of the amended Ruling No.1 under Rule 3 of Part III of the KSR will apply only to loans which are sanctioned on or after 01.02.2025—Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)— Section 37 - Idukki District Police Co-Operative Society Ltd.
