Advocates Act, 1961 (Central Act 25 of 1961)—Sections 8A and 35—When disciplinary proceedings are based on the complaint preferred by a Hon'ble Judge, it cannot be said that action initiated against appellant is suo motu—Rule cannot override specific provisions of the Act—Non-supply of audio/visual recordings of the Court proceedings to the appellant stating that the same is not available, amounts to miscarriage of justice—When Division Bench of High Court exonerated the appellant of similar charges in the contempt case, disciplinary committee of the Bar Council cannot take a different view or override the judgment of Division Bench on the same cause of action—In the light of exoneration of appellant in the contempt case, where identical verbatim complaints were referred to the Hon'ble Chief Justice and State Bar Council of Kerala, the issuance of a show cause notice and proceedings thereunder are absolutely unwarranted—Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015 (Central)—Rule 32—Constitution of India—Article 226 - Yeshwant Shenoy v. Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)—Sections 96, 106, 107 and 111(c)—Section 107 confers jurisdictional Magistrates with explicit authority to act swiftly in cases involving proceeds of crime—Logic behind the distinction with respect to seizure under Section 106 and attachment under Section 107, explained—Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Section 102 - Headstar Global Pvt. Ltd. v. State of Kerala and others -I.L.R. 2025 Kerala

Constitution of India—Article 226—The State is not entitled to levy internship fees from medical graduates—G.O. (Rt) No. 987/2025/H&FWD dated 03.04.2025, issued by the Additional Secretary, Health and Family Welfare (S) Department, Government of Kerala, declared illegal and ultra vires - Sharooq Mohammed and others v. Court fee—Refund of—The refund of court fees is permissible only if the matter is referred to Arbitration, Conciliation, Judicial settlement, including through Lok Adalat or Mediation for settlement and the case is decided in terms of such a settlement and not otherwise—Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 89 - Jage Ram v. Family Courts Act, 1984 (Central Act 66 of 1984)—Section 44—Minor can claim

Food Safety and Standards Act, 2006 (Central Act 34 of 2006)—Section 42—Time limit for making the recommendation under Section 42(3) is not mandatory—The absence of consequences for non-compliance, as well as the provision for filing an appeal and the procedure to be followed upon filing an appeal, clearly indicate that the provision is only directory, although the expression used is 'shall'—Food Safety and Standards Rules, 2011 (Central Rules) - Sreehari R. and another v. Income Tax Act, 1961 (Central Act 43 of 1961)—Section 144C (13)—The Assessing Officer is bound to adhere to the time limit stipulated in Section 144C (13) and any assessment order issued in breach of the time limit is invalid - IBS Software Services Private Limited v. Kerala High Court Act, 1958 (Kerala Act 5 of 1959)—Section 5—Intra court appeal against interim order—An appeal would lie against interim order in pending Writ petition only if the order substantially affect or touch upon the rights or liabilities of the parties or are matters of moment and cause serious prejudice to the parties—A person who got the interim order sought by him in Writ petition cannot file appeal against such interim order - Principal, Century International Institute of Dental Science and Research Centre v. Union of India and others -I.L.R. 2025 Kerala OnLine 211 : [Neutral Citation No. 2025:KER:36793](#)

Special Marriage Act, 1954 (Act 43 of 1954)—Section 37—Order for permanent alimony can be varied, modified or rescinded, if there is change in circumstance - Sharooq Mohammed and others v. State of Kerala and others - I.L.R. 2025 Kerala OnLine 208 : [Neutral Citation No. 2025:KER:38557](#)
