Banking Regulation Act, 1949 (Central Act 10 of 1949)—Section 36AAA—Consultation with State Government—When Proviso to Section 36AAA(1) provides for mandatory consultation with the State Government, any order passed without such consultation is to be held unsustainable - Jackson M.P. v. Banking Regulation Act, 1949 (Central Act 10 of 1949)—Section 36AAA—Principles of Natural justice—When the Legislature has decided to avoid the application of the principle of natural justice to proceedings under Section 36AAA, it could not be read into the language of the said provision—Section 36AAA of the Banking Regulation Act does not contemplate an opportunity of hearing before passing an order - Jackson M.P. v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 11, Explanation IV—Constructive res judicata mandates that all grounds that might and ought to have been employed in the proceedings, should be employed to avoid multiplicity of proceedings—Principle of constructive res judicata is founded on public policy and it also applies to the proceedings under Article 32/226 of the Constitution of India—Constitution of India—Articles 32 and 226 - Makardhwaj Ram v. Jagdish Rai

Constitution of India—Article 226—Judicial review of preventive detention—The Court is only required to examine whether the challenge to order of preventive detention establishes that the power was not exercised for a proper purpose or on extraneous considerations or on a misconstruction of the statute or to nullify a successful order of granting anticipatory bail/bail—It is not the reasonableness of the reasons, but the existence of material which may lead to a conclusion that there is a strong and reasonable probability that this person, if allowed to move freely, having regard to his past antecedents, would indulge in such illicit trade and hence, is required to be detained - Sulaiman M.V. v. Constitution of India—Article 226—Writ Petition seeking credit of interest towards Fixed Deposit—Circular of the first respondent/Bank itself provides that on maturity, the Term Deposit is to be automatically renewed for the same period at the rate of interest prevailing on the date of maturity—There is nothing to be adjudicated in a Civil Court by adducing evidence in the matter—Complicated adjudication is not required even on admitted facts and hence, there is no absolute bar in entertaining Writ Petition—The dispute regarding the remaining amount can be easily adjudicated on the basis of the admitted facts with reference to the admitted documents produced by the parties - Narayan Bharathan v. Kerala Civil Services (Classification, Control and Appeal) Rules, 1960— Rules 11(1)(iii), 11(1)(vA), 15 and 16—Prior to the Amendment to Rule 11 w.e.f. 27.05.2002, withholding of increments with cumulative effect was a minor punishment falling under Rule 11(1)(iii)—Rule 16, which governs procedure for minor penalties under Rule 11(1)(i) to (iv), does not contemplate a formal enquiry; it requires only issuance of a Statement of Allegations, an opportunity to the employee to submit a Representation, and passing of a reasoned order by the Disciplinary Authority considering such Representation—Where the Disciplinary Authority passed its penalty order on 14.08.1997, prior to the Amendment dated 16.05.2002 (w.e.f. 27.05.2002) by which a new Item (vA) was inserted into Rule 11(1) to separately classify withholding of increments with cumulative effect and exclude it from the minor penalty provision under Item (iii), the proceedings were governed by the unamended Rule 11(1), under which the said punishment was a minor penalty, and no enquiry was required—Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 114, Order XLVII Rule 1—Constitution of India—Article 226 - Managing Director, Kerala State Civil Supplies Corporation and another v. Prevention of Corruption Act, 1988 (Central Act 49 of 1988)—Sections 7, 13(1)(d) read with 13 (2)—Proof of demand and acceptance of illegal gratification by a public servant is the sine qua non to sustain conviction under the above provisions—Such proof may be by direct oral or documentary evidence, or by circumstantial evidence, and the mode of proof may also be the evidence of any witness other than the complainant, where the complainant is unavailable—Where the foundational facts of demand have been proved by relevant oral and documentary evidence, the Court has the discretion to raise a presumption of fact as to acceptance/obtainment, subject to rebuttal by the accused—Evidence of the complainant, even where minor omissions are elicited in cross-examination on comparison with the First Information Statement, need not be discarded in toto where the core testimony as to demand and acceptance remains intact and is otherwise corroborated - Jayanarayana D. v. Preventive detention—Delay between the prejudicial activity and order of detention—It is not fatal in every case provided the delay has been explained and if the live and proximate nexus between the prejudicial activities of the detenu and the necessity for preventive detention has not snapped - Sulaiman M.V. v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 243 : [Neutral Citation No.2026:KER:49522](#).

Preventive detention—Satisfaction of the detaining authority—Likelihood of conviction in criminal case is not germane—Whether the past conduct of the detenu furnishes a reasonable basis to apprehend his future involvement in prejudicial activities is an important consideration - Sulaiman M.V. v. Promotion of Tree Growth in Non-Forest Areas Act, 2005 (Kerala Act 46 of 2005)—Sections 2(e), 6 (7) and 7—An offence under Section 7 of the Act is predicated upon the unauthorised cutting, removal or disposal of a “specified tree” in contravention of the procedure prescribed under the enactment—The legislature has consciously restricted the operation of the regulatory mechanism to the specified trees alone and has not taken within its sweep all trees—The legislative intent is manifest that the restrictions and penal consequences contemplated under the Act are attracted only when the act complained of concerns a species recognised by the statute as a “specified tree”—The existence of a specified tree is therefore not a matter of evidence alone but constitutes a foundational jurisdictional fact necessary to attract penal consequences under the Act—Criminal law cannot proceed on assumptions or surmises—When a statute defines an offence and the circumstances under which the offence is attracted, the ingredients must prima facie find a place in the complaint—Promotion of Tree Growth in Non-Forest Areas Rules, 2011
