Administrative Tribunals Act, 1985 (Central Act 13 of 1985)—Sections 15(1)(a) and 19—Jurisdiction of the State Administrative Tribunal—The Kerala Administrative Tribunal will act like court of first instance in respect of the areas of law for which it has been constituted—Even in cases where the vires of statutory legislation (except that of the Administrative Tribunals Act) is under challenge, litigants have to approach the Kerala Administrative Tribunal, invoking the provisions under Section 19 of the Administrative Tribunals Act, 1985 - Sumith S. Pillai (Dr.) and others v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 201 : [Neutral Citation No. 2026:KER:34420](#).

Admiralty (Jurisdiction and Settlement of Maritime Claims) Act, 2017 (Central Act 22 of 2017)—Subsequent special enactment without any reference to earlier Act ought to prevail—Section 2(1)(c)(iii) of the Commercial Courts Act, 2015 does not confer admiralty jurisdiction on a commercial court—As per Section 3 of the Admiralty Act, 2017, the admiralty jurisdiction is exercisable solely by the High Courts—There is no reference to the Commercial Courts Act, 2015, in the Act 22 of 2017—If the claim in a suit is a maritime claim defined under Section 4 of the Admiralty Act, 2017, it is exclusively triable before the specified High Courts and not before any other Court - Commercial Courts Act, 2015 (Central Act 4 of 2016) – Section 2(1)(c)(iii) - India Steamship Company and another v. Gangadharan C.V. and another - I.L.R. 2026 Kerala OnLine 204.

Anatomy Act, 1957 (Kerala Act 17 of 1957)—Section 4A—Right of a person to donate his body to facilitate medical education—The right to posthumous bodily integrity allows an individual to determine the fate of his own body after death—The legal representatives cannot impose their will on the dead body of a person - Greeny Tomy and others v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 202 : [Neutral Citation No. 2026:KER:36320](#).

Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Difference in calculation of days of delay sought to be condoned—Where relief was for accepting the written statement to the file, difference of number of days is not fatal - India Steamship Company and another v. Gangadharan C.V. and another - I.L.R. 2026 Kerala OnLine 204.

Constitution of India—Article 226(2)—Territorial jurisdiction of High Court—Maintainability of writ petition—Petitioner, personal guarantor to credit facilities obtained by 3rd respondent company from 1st respondent bank, challenged order of NCLT Delhi permitting initiation of personal insolvency proceedings against him—Whether writ petition before High Court of Kerala maintainable where cause of action with reference to IBC arose outside the State—Article 226(2) permits filing of writ petition where part of cause of action has arisen within the State—Credit facility obtained in State of Kerala—However, proceedings before NCLT instituted under IBC—Registered office of 3rd respondent situated at New Delhi, not in Kerala—Cause of action with reference to IBC does not arise in State of Kerala—Writ petition under Article 226 would not lie before High Court of Kerala—Insolvency and Bankruptcy Code, 2016 (Central Act 31 of 2016)—Sections 60 and 95 - Marzook K.N. v. Dhanlaxmi Bank Limited and others - I.L.R. 2026 Kerala OnLine 208 : [Neutral Citation No.2026:KER:36249](#).

Constitution of India—Articles 14 and 226—Recruitment—Rank List—Indefeasible right to be appointed—Candidates included in Rank List do not obtain an indefeasible right to be appointed—Abolition of 34 vacancies in the category of Office Attendants during the currency of the Rank List, at the request of the High Court and accepted by the Government, held to be a policy decision—No allegation of mala fides or other vitiating factors imputed against abolition of posts—In the absence of such allegations, further evaluation under Article 226 is unnecessary and impermissible—Subsequent notification issued for vacancies arising after expiry of Rank List relates only to future vacancies and cannot be equated with abolished posts - Sreeparvathy R.S. and others v. Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Section 28 (1CA)—Kerala Co-operative Societies Rules, 1969—Rule 35A (4)—Election to Apex Society—In the absence of any provision that ensures that persons with the qualifications mentioned in Section 28 (1CA) of the 1969 Act will be nominated as delegates of primary societies, it would be impossible to apply the same to committees of apex societies—Provision through Section 28A (3) of the 1969 Act

expressly reserves to the Government or the Registrar the authority to nominate in case such a reservation is not achievable for any reason, such a provision is absent in Section 28 (1CA) of the 1969 Act—Voters' list is prepared with reference to the members and in a situation where the members are primary societies, the question of complying with the provisions of Rule 35A (4) of the 1969 Rules in the case of an apex society does not arise - Vattavila Vijayakumar v. Income Tax Act, 1961 (Central Act 43 of 1961)—Sections 2(28C), 271D, 271E and 274(2)—Section 2(28C) contemplates that Joint Commissioner includes Additional Commissioner—Prior approval for penalty proceeding by Additional Commissioner of Income Tax satisfies the requirement of prior approval of the Joint Commissioner under Section 274(2) of the Income Tax Act, 1961—Wherever the term 'Joint Commissioner' is used in the Act, it would include the 'Additional Commissioner' of Income Tax as well, unless statutorily contraindicated—Harmonious interpretation has to be made to all the provisions of an enactment, so that, no provision is made redundant - Service Co-operative Bank Ltd. No.F583 v. Assistant Commissioner of Income Tax and another - I.L.R. 2026 Kerala OnLine 205 : [Neutral Citation No.2026:KER:33197](#).

Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Sections 166 and 173—Compensation—Loss of dependency—Notional income—Deceased a salaried employee working as a sweeper—Claim for addition of notional amount towards homemaker services over and above proved income from salary—Deceased shown to have been in continuous employment at the time of accident—Tribunal's fixation of monthly income as per amount mentioned in salary certificate is in order - Thomas Poulose and others v. Albin Mathew @ Anto and another - I.L.R. 2026 Kerala OnLine 207 : [Neutral Citation No.2026:KER:38210](#).

Registration of Births and Deaths Act, 1969 (Central Act 18 of 1969)—Though there is no provision in the Act to correct the name of the child or to add the father's name to a child born to a single mother, High Court can exercise its extraordinary jurisdiction under Article 226 of the Constitution of India in appropriate cases to make necessary corrections—Constitution of India- Article 226 - Anju Krishna and another v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 203 : [Neutral Citation No.2026:KER:37687](#).

Service—Compassionate Employment Scheme—Petitioner engaged on daily wage basis under order containing condition that she shall not raise any claim for permanent appointment—Whether such condition bars claim under Compassionate Employment Scheme—No undertaking given by petitioner in daily wage appointment order forgoing right to compassionate appointment—Compassionate Employment Scheme treated as exemption to help family survive sudden financial destitution—Ban on regular recruitment cannot be a reason for not considering claim for compassionate appointment—Claim cannot be rejected on ground of delay where

delay is attributable to want of vacancies - Sangeetha K.P. v. Plantation Corporation of Kerala Ltd. and another - I.L.R. 2026 Kerala OnLine 209 : [Neutral Citation No.2026:KER:38231.](#)
