Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Order XXI, Rules 97 and 99— Maintainability of Claim Petition—A third party to the decree may resist execution under Order XXI Rule 97 CPC, and need not wait until actual dispossession to invoke the jurisdiction of the executing court - Muhammed Yasir v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Order XXIII, Rule 1(4)— Withdrawal of earlier suit without liberty—Where a prior suit for the same relief was

withdrawn as “not pressed” without liberty, a fresh claim on the same cause of action is barred; such a claim cannot be revived through execution proceedings under Order XXI Rules 97/99 CPC - Muhammed Yasir v. Evidence Act, 1872 (Central Act 1 of 1872)—Section 47—A person who is acquainted with another person's handwriting is to be examined in a prosecution to prove the same - His evidence must detail the manner in which he became acquainted with the handwriting or signatures, according to the three modes provided in the explanation to Section 47—Prevention of Corruption Act, 1988 (Central Act 49 of 1988)—Sections 13(1) and 13(2)—Penal Code, 1860 (Central Act 45 of 1860)—Sections 409, 420, 468, 471, 477A and 120B - Manmadhan v. Immoral Traffic (Prevention) Act, 1956 (Central Act 104 of 1956)—Sections 3 and 4— Only a person keeping or managing, or acting or assisting in the management of a brothel can be prosecuted and punished for the offence under Section 3—Section 4 is attracted only in respect of a person living on the earnings of prostitution of another person - Sarath Chandran v. State of Kerala - I.L.R. 2025 Kerala OnLine 306 : [Neutral Citation No. 2025:KER:59585.](#)

Immoral Traffic (Prevention) Act, 1956 (Central Act 104 of 1956)—Section 5 (1) (d)—A person availing the services of a sex worker in a brothel is actually inducing that sex worker to carry on prostitution by paying money and is therefore liable to be prosecuted for the offence under Section 5 (1) (d) of the Act—Such a person cannot be called a customer - Sarath Chandran v. Income Tax Act, 1961 (Central Act 43 of 1961)—Section 269 SS—Any violation of Section 269 SS would not render the transaction unenforceable under Section 138 of the NI Act or rebut the presumptions under Sections 118 and 139 of the NI Act because such a person, assuming him/her to be the payee/holder in due course, is liable to be visited by a penalty only as prescribed - Negotiable Instruments Act, 1881 (Central Act 26 of 1881)—Section 138 - Sanjabij Tari v.
