Buildings (Lease and Rent Control) Act, 1965 (Kerala Act 2 of 1965)—Determination of fair rent requires consideration of prevailing rent of similar buildings, with comparable facilities and conditions—Enhancement of rent applies from the date of the Commission Report - Kakkoth Saseendran v. Commercial Courts Act, 2015 (Central Act 4 of 2016)—Sections 3(1), (2) and 15—Suit for recovery of money on pro-note pending before Munsiff Court—Government notification during pendency of suit designating Sub Courts as Commercial Courts for recovery of amounts exceeding 3,00,000/- Suit not transferred to Commercial Court despite notification—Munsiff Court proceeded to adjudicate suit on merits without effecting transfer—First appellate Court (Sub Court) affirmed decree without noticing the jurisdictional defect—When notification is issued by the State of Kerala designating Sub courts as commercial courts for recovery of amount above 3,00,000/-, necessarily the Munsiff Court ought to have transferred the suit to the Principal Sub Court—Without transferring the same, the act of the Munsiff Court in proceeding to consider the suit on merits is clearly unsustainable and without jurisdiction— Civil Procedure Code, 1908 (Central Act 5 of 1908) - BRD Finance Ltd. v. Constitution of India—Articles 124(3)(b), 217(2)(b) and 233(2)—Judicial Service—Recruitment to the post of Civil Judge (Junior Division)—Eligibility condition of minimum three years' practice at the Bar—The desirability of some prior exposure to the functioning of courts before entry into judicial service is not itself open to review and is reaffirmed; But the manner of enforcement of the three-year requirement calls for a limited, transitional intervention - Duration of Bar practice alone is an imperfect measure of practical readiness for judicial office, and structured post-selection training together with supervised Law Clerkship may legitimately be treated as equivalent, in part, to years of practice at the Bar—New scheme framed for recruitment of Civil Judge (Junior Division)—New scheme to be valid for 5 years [Majority View] - Bhumika Trust v. Constitution of India—Articles 124(3)(b), 217(2)(b) and 233(2)—Judicial Service—Recruitment to the post of Civil Judge (Junior Division)—Scheme applicable to notification issued after 01.04.2027 to the post of Civil Judge (Junior Division) framed—All notifications issued after the date of Judgment under review till date will be governed by the scheme framed in this order - [Majority View] - Bhumika Trust v. Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Section 69—The provisions of the Consumer Protection Act, 1986/2019 are in addition to and not in derogation of the provisions of any other law for the time being in force—Even if the 1969 Act starts with a non-obstante clause, the provisions of Section 69 do not oust the jurisdiction of the forums under the Consumer Protection Act—Precedents discussed—Consumer Protection Act, 2019 (Central Act 35 of 2019)—Constitution of

Co-operative Societies Rules, 1969 (Kerala)—Rule 35A (4)—“Any other restriction, if imposed in this regard, shall be declared as null and void”, occurring in the Explanation to Rule 35A (4) of the Kerala Co-operative Societies Rules, 1969, relates only to the prescription that every ‘A’ Class member who has subscribed to the minimum share value shall be eligible to vote and contest in the election—Precedents discussed—Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Section 28 - Ramachandran Nair v. Kattakkada Primary Co -Operative Agricultural Development Bank Ltd. No. T 2037 and Others - I.L.R. 2026 Kerala OnLine 276 : [Neutral Citation No.2026:KER:48563](#).

Education Rules, 1959 (Kerala)—Chapter XIVA, Rule 45A—As per Rule 45A of Chapter XIVA and Rule 3 of Chapter XXXI, it can only be said that the B.Ed. training qualification is also one of the prescribed qualifications for appointment to the post of Head Master of a lower primary school—Rule 45A refers to any other equivalent training qualification prescribed for appointment as ‘Primary School Assistant’ and does not differentiate between LPSA and UPSA—Chapter XXXI, Rule 3 - Jisha M.V. v. Najmudden K.P. and others - I.L.R. 2026 Kerala OnLine 278 : [Neutral Citation No.2026:KER:62494](#).

High Court Act, 1958 (Kerala Act 5 of 1959)—Section 5(i)—An Appeal can be filed against an interlocutory order when such order is one without jurisdiction, contrary to law, perverse or causes serious prejudice to the parties - Prasanth B. and another v. Hoysala Projects Private Limited and others - I.L.R. 2026 Kerala OnLine 281 : [Neutral Citation No.2026:KER:37190](#).

Real Estate (Regulation and Development) Act, 2016 (Central Act 16 of 2016)—Section 18(1), 43(5) and 58—Courts cannot, by interim orders, substitute a legislative policy choice with an alternative benchmark—Courts cannot enter the legislative domain by way of rewriting a statutory rule or inserting new language under the guise of judicial interpretation—The mandatory pre-deposit condition is binding and the same cannot be undermined or diluted by any order - Distinction between Benchmark Prime Lending Rate, Marginal Cost of Funds based Lending Rate and External Benchmark Lending rate, explained—Real Estate (Regulation and Development) Rules, 2018 (Kerala)—Rule 18 - Prasanth B. and another v.
