#### I.L.R. - Index of report cases dt. 08.04.2026

**Administrative Law**—Discretion must be based on objective considerations and the exercise of the power must be influenced by factors that are lawfully to be taken into account and not by ignoring or disregarding the relevant factors—If the relevant factors are not reckoned and irrelevant aspects are made the basis of a decision, the order faces the risk of being interfered with as being arbitrary or unreasonable—Constitution of India — Article 226 - Fazeela R.A. and another v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 107: [Neutral Citation No. 2026:KER:27267](#).

**Anti-Social Activities (Prevention) Act, 2007 (Kerala Act 34 of 2007)**—Section 2(j)— ‘Goonda’—A person need not concurrently satisfy both limbs of Section 2(j) of the KAAPA (indulging in anti-social activity and promoting illegal activity harmful to public order) to be declared a ‘Goonda’ - Aaliya Ashraff v. State of Kerala and others - [I.L.R. 2026 Kerala OnLine 105 \(LB\)](#).

**Anti-Social Activities (Prevention) Act, 2007 (Kerala Act 34 of 2007)**—Section 2(i)— ‘Stocks’—It refers to keeping an article for future use regardless of quantity or quality— The word ‘stock’ is used in contradistinction with the word ‘Possession’ to ensure all drug offences, including those involving small quantities, fall within the ambit of ‘anti-social activity’ - Aaliya Ashraff v. State of Kerala and others - [I.L.R. 2026 Kerala OnLine 105 \(LB\)](#).

**Anti-Social Activities (Prevention) Act, 2007 (Kerala Act 34 of 2007)**—Section 2(j)— ‘Goonda’—For a person to be declared a ‘Goonda’, the imputed ‘anti-social activity’ does not always have to be of a kind that is harmful to the maintenance of ‘public order’ in the strict sense - Aaliya Ashraff v. **Constitution of India**—Article 226—Writ Petition challenging propriety of transfer of playground of a Government School for constructing a building for a Music College— Construction of a College for Music is an educational purpose and there cannot be any embargo under Section 5B of the Act—Kerala Education Act, 1958 (Kerala Act 6 of 1959)— Section 5B - Fazeela R.A. and another v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 107: [Neutral Citation No. 2026:KER:27267.](#)

**Criminal Trial**—It is incumbent upon the trial Courts dealing with criminal proceedings to inform the accused of their right to legal representation and their entitlement to be represented by legal aid counsel in the event they cannot afford a counsel—Trial Courts shall record the offer made to the accused in this regard, the response of the accused to such offer and also the action taken thereupon in their orders, before commencing examination of the witnesses - Reginamary Chellamani v. **Environmental Law**—Sustainable Development—Biodiversity of Madayipara—Conflict between infrastructural development and ecological preservation—Mitigation measures ordered by High Court - Vijesh C.K. v. **Hindu Religious and Charitable Endowments Act, 1951 (Madras Act 19 of 1951)**—Section 29—Temporary surrender of temple land for road widening—Whether prior sanction of the Commissioner is mandatory—Prior sanction is not required as temporary surrender of land cannot be construed as transfer of interest in immovable property - Vijesh C.K. v. State of Kerala and others - I.L.R. 2026 Kerala OnLine 106 : [Neutral Citation No.2026:KER:25499.](#)

**Motor Vehicles Act, 1988 (Central Act 59 of 1988)**—Gratuitous Passenger in Goods vehicle suffered injury—Insurer cannot be exonerated from the liability - Insurer is liable to pay the amount and to recover the amount from owner of the vehicle - Shaji v. **Motor Vehicles Act, 1988 (Central Act 59 of 1988)**—Section 173—Notional Income fixed by Tribunal erroneous—Claimant, a catering worker, is entitled to notional income of 6,000/- per month - Shaji v. Soman and another - I.L.R. 2026 Kerala OnLine 108 : [Neutral Citation No.2026:KER:26694](#).

**Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985)**— Offences under the Act cannot be termed as 'Petty offences'—Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)—Section 229 (2) - Aaliya Ashraff v. State of Kerala and others - [I.L.R. 2026 Kerala OnLine 105 \(LB\)](#).

**Service**—Death of the petitioner's husband due to heart attack will come within the purview of Clause (a) of Ext.P1 which provides for death occurring due to accidents in the course of performance of duties, and she is entitled for the ex gratia lumpsum compensation - Sobhana Mohan v. Union of India and others - I.L.R. 2026 Kerala OnLine 104 : [Neutral Citation No.2026:KER:12789](#).

**Service**—Marital status of the surviving wife of the deceased employee is the sole criteria for the grant of family pension—Dependency condition applies only to parents, unmarried widow, daughters and disabled children—Board is duty bound to ensure the eligibility of the persons appointed under compassionate employment scheme—The wife is entitled for family pension, when the allegation of fraud with respect to securing of employment by the deceased husband, is not proved—Service Rules, 1966 (Kerala)—Part III, Rule 90 - Ambika K.N. v.
