Abkari Act, 1967 (Kerala Act 1 of 1967)—Section 53A—The act of certifying an inventory under Section 53A is not an empty formality, especially since such inventory is treated as primary evidence in an Abkari case—While certifying the inventory, the Magistrate is expected to exercise due care and caution, bearing in mind that the document so certified would assume the character of primary evidence during trial - Raju A. v. Arbitration and Conciliation Act, 1996 (Central Act 26 of 1996)—Government officer appointed Arbitrator—An Arbitrator is not bound by a Government order or direction and is expected to discharge his duty independently— National Highway Act, 1956 (Central Act 48 of 1956)—Section 3G - Abdurahiman Veeroli v. National Highway Authority of India and another - I.L.R. 2026 Kerala OnLine 174 : [Neutral Citation No.2026:KER:4690](#).

Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)—Section 187(3)(i)—The sixty-day and ninety-day framework remains intact, with only minor changes in the phraseology of both Sections - Default bail is linked to the seriousness of the offense—Distinction between the sixty-day and ninety-day time frames explained—As the offence under Section 22(b) of the NDPS Act provides for a maximum punishment of ten years with fine, but stipulates no minimum term, the

statutory right to bail accrues if the final report is not filed within sixty days from the date of custody—Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Section 167(2)—Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985)—Section 22(b)—Constitution of India—Article 21 - Aboobacker Siddique and another v. Bharatiya Nagarik Suraksha Sanhita, 2023 (Central Act 46 of 2023)—Section 187(3)(i)—Conjoint reading of Rules 13(1) and 13(2) of the Electronic Filing Rules with Rules 4 and 5 of the Criminal Rules of Practice makes it evident that, for the purpose of computing limitation, electronic filings received up to 5:00 p.m. shall be treated as instituted on that day—Electronic Filing Rules for Courts, 2021 (Kerala)—Rule 13—Criminal Rules of Practice, 1982 (Kerala)—Rules 4 and 5—Limitation Act (Central Act 36 of 1963) -Aboobacker Siddique and another v. State of Kerala and another - I.L.R. 2026 Kerala OnLine 177 : [Neutral Citation No.2026:KER:37508](#).

Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Order VII Rule 3—It would be imprudent to hold that when the boundary of the plaintiff's property is disputed by the defendant who is the adjacent property owner, the plaintiff cannot file a suit for determination of the boundary of his property, if he is unaware of the details of the property of the defendant—It would be sufficient to indicate, while describing the plaintiff's property, the common boundary shared with the defendant, and such description satisfies the requirements of Order VII Rule 3 - Sukumaran Nair K.N. v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Sections 16 and 17—Mere existence of one item out of several items of properties or even a portion of any of the items, within the territorial limits, would be sufficient to confer jurisdiction on the Court—Contention regarding lack of territorial jurisdiction should have been raised before the trial court at the earliest possible opportunity—Dispute between the legal heirs of the deceased member of a co-operative society cannot be considered as a matter touching the business of the society—Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Sections 2(i), 69 and 100 - Surendran P.V. v. Kavitha Rajendran (Died) and others - I.L.R. 2026 Kerala OnLine 175 : [Neutral Citation No.2026:KER:35893](#).

Penal Code (Central Act 45 of 1860)—Section 307—Effect of post-conviction compromise—Settlement can have an impact in the matter of reduction of sentence - Unnikrishnan and others v. State of Kerala and another - I.L.R. 2026 Kerala OnLine 173 : [Neutral Citation No.2026:KER:34413](#).

Law of Evidence—Injured Witness—Testimony of injured witness on a better footing—It is a well settled law that the evidence of an injured witness carries more credibility since he would speak of the occurrence with assurance of truth with mark and seal of the injuries he suffered - Unnikrishnan and others v. Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Notional income— 4,500/- taken as notional income is too low for a claimant who is residing abroad—Future prospects ought to have been included in computation - Ummer C.K. v. Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Sections 166 and 168—Just Compensation—Deductibility of Medclaim/Medical Insurance from MACT Award—The amount received as part of Medclaim/Medical insurance is not deductible from compensation as calculated by the concerned Tribunal, while adjudicating a claim for compensation, which may also include compensation under the head of medical expenses - New India Assurance Co. Ltd. v. Dolly Satish Gandhi and another - I.L.R. 2026 Kerala OnLine 181 (SC) : [Neutral Citation No.2026 INSC 498](#).

Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Section 168—Permanent disability—A prosthetic limb is not a one-time expense—It requires periodic replacement, maintenance, physiotherapy and adaptation over the claimant's lifetime—Restitutio in Integrum—Purpose of compensation under the Motor Vehicles Act is to adequately restore the aggrieved to the position prior to the accident as best as possible- Ummer C.K. v. Oriental Insurance Company Ltd. - I.L.R. 2026 Kerala OnLine 172 : [Neutral Citation No.2026:KER:35025](#).

Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989 (Central Act 33 of 1989)—Section 3(1)(s), 3(1)(w)(i) and 3(2)(va)—Presence of the public to witness the occurrence or hear the abusive words, even in a private place, would make such a private place within public view for the purposes of SC/ST (POA) Act - Santosh Kumar v. State of Kerala and another - I.L.R. 2026 Kerala OnLine 179 : [Neutral Citation No. 2026:KER:35838](#).

Service—Kerala State Electricity Board employee—He is entitled to count his previous service with Railways as qualifying service for the purpose of Pension and Gratuity - Bency John v. Kerala State Electricity Board Ltd. and others - I.L.R. 2026 Kerala OnLine 178 (SC) : [Neutral Citation No.2026 INSC 562](#).

Service—Railway employee—Service under the Railway Board in the broader sense is service under the Central Government, and a railway servant does not cease to be a member of the civil service of the Central Government merely because his conditions of service are regulated by rules specific to the Railway - *Bency John v.
