Buildings (Lease and Rent Control) Act, 1965 (Kerala Act 2 of 1965)— Section 12 (1)—In an appeal filed by Tenant against order under Section 12 (3), fresh application under Section 12 (1) need not be filed by the Landlord before the appellate authority - Sidhique P.U. and others v. Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 114—Fraud on the court by suppression of a material fact—Suppression of any and every fact will not amount to fraud, rendering the judgment a nullity—Where facts are known to both the parties, the omission by one does not render it suppression—Suppression of material fact cannot be alleged unless the person was aware of the so-called suppression of fact—Order 47 Rule 1 - Usha Umesh (Dr.) v. Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Sections 167(2), 437(3) and 439—Default bail—Foreign national—Bail conditions—Magistrate/Sessions Court has no power, while granting bail, to impose a condition directing detention of the accused in a detention home or transit home, till conclusion of the trial—Power to detain or restrict the movement of a foreigner vests exclusively in the civil authorities under the Foreigners Act, 1946 and the Foreigners

Evidence Act, 1872 (Central Act 1 of 1872)—There is no rigid or inflexible rule requiring the evidence of a related witness to be viewed with suspicion in all circumstances—When there is convincing direct ocular evidence, the proof of motive holds relatively little significance— Penal Code, 1860 (Central Act 45 of 1860)—Section 302 - Shyju v. Interpretation of Statutes—Courts must balance textual fidelity with interpretive wisdom, ensuring that laws are not applied mechanically without considering context or equity; but serve as true vehicles for the administration of justice - Sidhique P.U. and others v. Local Authorities (Disqualification of Defected Members) Rules, 2000 (Kerala)—Rule 4 (2)—Presumption can be drawn with regard to the endorsement on the postal article also, unless proved otherwise—When there is no proof of the fact that the writ petitioner kept himself away from the house after intimating the same to the authorities concerned as claimed by him, it is only to be inferred that the service of said whip is deemed to be effected—General Clauses Act, 1897 (Central Act 10 of 1897)—Interpretation and General Clauses Act, 1125 (Kerala Act VIII of 1125 ME)—Section 26 - Mini Savio v. Local Authorities (Prohibition of Defection) Act, 1999 (Kerala Act 11 of 1999)—Sections 3 and 4—A whip issued by the person authorized to recommend the political party's symbol during an election is sufficient to establish the validity of such whip— Scheme of Rule 4(2) examined—Local Authorities (Disqualification of Defected Members) Rules, 2000 (Kerala Rules)—Rule 4 - Mini Savio v. Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (Central Act 56 of 2007)—Section 23—Where the document of transfer by Senior citizen does not provide that the transferee shall provide the basic amenities and physical needs to the transferor unless the undertaking or promise of the transferee, as required under Section 23, is established either through oral evidence, pleadings or otherwise, the maintenance Tribunal cannot declare that the document is void - Subha Jayakrishnan v. Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (Central Act 56 of 2007)—Section 23—Transfer made by senior citizen even to a non- relative can be set aside if the conditions contemplated by Section 23 is satisfied - Subha Jayakrishnan v. Penal Code, 1860 (Central Act 45 of 1860)—Section 302—Even if there is a minute difference in the opinion of medical experts, the Court can very well consider which one is the probable one—A doctor engaged in emergency clinical care is not expected to determine the precise cause of death, as such determination is the responsibility of the forensic surgeon who conducts the autopsy—Even in the absence of a specific deposition by the doctor stating that the injury was sufficient, in the ordinary course of nature, to cause death, the court can independently assess whether the injury was likely to result in death by carefully examining the nature of the wound, the part of the body affected, and the weapon used— Evidence Act, 1872 (Central Act 1 of 1872) - Shyju v. Prisons and Correctional Services (Management) Rules, 2014 (Kerala)—Rule 400(1)— The term ‘direct nephew’/‘direct niece’ cannot be interpreted to mean only the sister’s son or daughter—The exclusion of the convict’s brother’s son or daughter from Rule 400(1) would amount to violation of Articles 14 and 15 of the Constitution of India— Constitution of India—Articles 14 and 15 - Shaduli P.M. v.
