Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 92—Two or more persons should be the petitioners for filing a petition under Section 92—This is a mandatory prerequisite - If two petitioners are not there, additional petitioners cannot be impleaded in the petition to cure the defect - Order I, Rule 10(2) - Nair Service Society and others v. Evidence Act, 1872 (Central Act 1 of 1872)—Sections 101 and 102— Burden of Proof in a Claim by wife for return of gold ornaments and cash- Proof of entrustment is the key element—Petitioner has to present cogent evidence regarding ownership, entrustment and failure to return - Muneera v. General Clauses Act, 1897 (Central Act 10 of 1897)—Section 3 (42)—‘Person’ under Section 92 of CPC does not include unincorporated association—Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 92 - Nair Service Society and others v. Hindu Law—Partition—Every Hindu family is presumed to be joint but there is no

Income Tax Act, 1961 (Central Act 43 of 1961)—Sections 11, 12, 12A and 139(4A)—Claiming exemptions under Sections 11 and 12 by charitable institutions registered under Section 12A—Benefit of exemption is conditional upon the filing of a return of income if the gross income, before giving effect to such exemption, exceeds the maximum amount not chargeable to tax—Non-filing of return disentitles party from exemption - Lisieux Educational Institutions v. Service—Disciplinary proceedings—If the charge is vague and lacking in particulars, the enquiry conducted pursuant to such memo of charges is illegal and liable to be set aside - Sankaran Namboothiri P. v. Special Rules for the Kerala Social Welfare Subordinate Service (Amendment), 2012—The applicable Special Rules do not prescribe any experience requirement for Anganwadi Workers with degree for appointment to the post of Supervisor (ICDS)—Kerala Public Service Commission is not legally empowered to introduce an experience criterion in the recruitment notification in contravention of the Rules— Lini Joy C. V. Kerala Public Service Commission, Tvm and Another, 2017 (2) KHC 474, held per incuriam - Sakeena K.A. v. Stamp Act, 1899 (Central Act 2 of 1899)—Section 8F—Section 5(1A) of the SARFAESI Act read with Section 8F of the Indian Stamp Act, 1899 cannot be relied on to claim exemption from payment of stamp duty payable under Kerala Stamp Act—Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (Central Act 54 of 2002)—Section 5(1A) – Stamp Act, 1959 (Kerala Act 17 of 1959) - J.C. Trusts Act, 1882 (Central Act 2 of 1882)—Section 63—Even if the property was purchased by the father and mother utilizing funds of the minor, the minor cannot claim share over the property but the minor can claim return of the amount with interest - Mini Vinod Kumar v.
