Co-operative Societies Rules, 1969 (Kerala)—Rule 198—To conduct an enquiry under Rule 198 necessarily means two things: first, the enquiry must comply with the principles of natural justice, and secondly, its findings must be defensible based on the materials on record—If enquiry officer enters findings which are based on no evidence at all, then it would be futile to contend that enquiry is one conducted in accordance with the provisions of Rule 198—The finding that enquiry is found to

have been conducted in substantial compliance with the provisions of Rule 198, would not divest the authority of the Co-operative Arbitration Court, to consider whether the order of termination is one passed on proper material or not—Reinstatement ordered by the Co-operative Arbitration Court upheld—Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Section 69 - Kuttamperoor Service Co-operative Bank Ltd. and another v. Motor Vehicles Taxation Rules, 1975 (Kerala)—Rule 15A—Refund of one-time motor vehicle tax—Rejection of refund application on ground of limitation is erroneous—Date of re-registration in transferee State to be considered as starting point for limitation, not the actual date of No Objection Certificate (NOC)—Rules do not mandate date of NOC as date of removal – Refund claim can be made only after re-registration and tax payment in transferee State, as per Rule 15A(2) (iii)—Application filed within one year from date of re-registration is within time—Rejection of refund application set aside—Kerala Motor Vehicles Taxation Act, 1976 (Kerala Act 24 of 1976)—Section 6(2)—Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Section 47 - Sharanya Vijay K. v. Protection of Women from Domestic Violence Act, 2005 (Central Act 43 of 2005)—Sections 18, 19, 20, 21, 22, 26 read with Section 36—Reliefs under the Act can be sought in addition to and not in derogation of other legal remedy—To grant a relief under the Act, the only consideration is whether a woman has been subjected to domestic violence or not - Omana Thomas v.
