Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Section 47—Order XXI, Rules 97 & 103—A judgment debtor may maintain a separate suit to challenge a decree on the ground of fraud and collusion—Such a claim is not barred under Section 47 or Order 21 Rule 101 CPC— Maintainability in such circumstances involves mixed questions of fact and law and cannot be disposed of as a preliminary issue under Order XIV Rule 2 CPC - Order XIV, Rule 2 - Ahamed Basher v. Electricity Act, 2003 (Central Act 36 of 2003)—Sections 79 (1) and 111—Central Electricity Regulatory Commission—Distinction between Regulatory and Adjudicatory Functions—Since Regulatory powers under Section 79 (1) are of an ad hoc nature and are not of general application, the orders thereunder are made appealable under Section 111—Order of the Central Electricity Regulatory Commission cannot be challenged in Writ petition—Constitution of India—Article 226 - Power Grid Corporation of India Limited v. Negotiable Instruments Act, 1881 (Central Act 26 of 1881)—Section 142(2)(a)—Territorial jurisdiction for instituting a complaint—Jurisdiction is vested in

the Court where the cheque is delivered for collection, that is, through an account in the branch of the Bank where the payee maintains that account - Prakash Chimanlal Sheth v. Jagruti Keyur Rajpopat - I.L.R. 2025 Kerala OnLine 264 (S.C.) : [Neutral Citation No.2025 INSC 897](#)

Penal Code, 1860 (Central Act 45 of 1860)—Section 498(A)—Petty domestic quarrels or ordinary wear and tear of marital life do not constitute cruelty—Only those acts which fall within either limb of the Explanation to Section 498(A) would amount to “cruelty”—A continuing course of conduct is not essential; even a single act may suffice if it is grave enough to satisfy the statutory definition of cruelty - Sajudheen and others v. Sale of Goods Act, 1930 (Central Act 3 of 1930)—Sections 55 and 56—When a buyer of goods fails or neglects or refuses to accept the goods, the seller can file only a suit for damages for non-acceptance and not for the price of goods - M/s. State and Subordinate Service Rules, 1958 (Kerala)—Rule 10 (a)(ii)—The sufficiency of a higher qualification which presupposes the acquisition of a lower qualification must be decided with reference to the qualifications prescribed under the Special Rules or Executive orders— Government as well as Public Service Commission are competent to determine sufficiency of a qualification under Rule 10 (a)(ii)—Personnel and Administrative Reforms Department of the Government is the competent department to take such a decision—Any such decision of other departments can be taken only as a recommendation for the final decision by the Personnel and Administrative Reforms Department— Decision of Government Department or the PSC must precede the issuance of the notification, so that such decision can be applied and reflected in the notification itself—Extent of judicial review is limited to examining whether the decision was made following test applied in re Jyoti and also based on qualifications referred to in Special rules or executive orders - Kerala Public Service Commission v.
