Conservation of Paddy Land and Wetland Rules, 2008 (Kerala)—Form 5—Order passed on form 5 should be a speaking order setting out concisely the reasons for passing such an order—In future, if an order passed in a Form-5 application is not a speaking order, High Court will be forced to direct the Officer concerned to pay costs to the litigant for unnecessarily dragging him to Court again and again—Administrative law—Speaking order - Vinumon C. v. District Collector and others - I.L.R. 2025 Kerala OnLine 349: Neutral Citation No. 83912.

Constitution of India—Article 19 (1) (a)—The regulatory power of the State to impose reasonable restrictions on the fundamental right to free speech and expression can only be in the interest of the sovereignty and integrity of India, the security of the State, friendly relations with Foreign States, public order, decency or morality or in relation to contempt of court, defamation or incitement to an offence—The standard to be applied by the censor Board or the courts for judging the film should be that of an ordinary man of commonsense and prudence and not that of an out of the ordinary or hypersensitive man—Cinematograph Act, 1952 (Central Act 37 of 1952)—Section 5B - Juby Thomas and another v. Constitution of India—Article 226—Public duty is the constitutional trust reposed in all holders of public power, and it is through public accountability that the exercise of

public power retains its legitimacy—The Kerala Cricket Association is amenable to the writ jurisdiction under Article 226 on account of the public duties it discharges—Office bearers of KCA are 'public servants' within the meaning of Section 2(c)(viii) of the Prevention of Corruption Act, 1988, in relation to the public duties discharged by them—Section 2(c)(viii)—The Prevention of Corruption Act, 1988 (Central Act 49 of 1988) - Harish V. v. Conservation of Paddy Land and Wetland Rules, 2008 (Kerala) —Form 5 - Duty of Public servant—Officers of the Government should be careful in passing orders on applications submitted by citizen, pursuant to direction of the High Court—If the carelessness of the officer results in forcing the party to approach the High Court again, the officer responsible will have to pay costs to the party in addition to facing disciplinary proceedings— Vinumon C. v. District Collector and others - I.L.R. 2025 Kerala OnLine 349: Neutral Citation No. 83912.

Finance (No.2) Act, 2019 (Central Act 23 of 2019)—Section 127—Judicial/quasi judicial and administrative acts are completely different in their powers and consequences, even though the difference between them very is thin—Requirements qualify proceeding judicial/quasijudicial, to а as examined-While considering the case of an assessee under the scheme, the authority is under an obligation to act judicially, and there would be a determination of the tax to be paid—Such proceedings or the acts that are being carried out by the designated authority could be treated as a mere administrative action, but on the other hand, it amounts to a guasi judicial act— Time extension granted by the Honourable Supreme Court in connection with Covid-19 pandemic with respect to limitation, is applicable to the proceedings—Court explained the word 'proceedings' in the background of limitation extension orders—Sabka Vishwas (Legacy Dispute Resolution) Scheme Rules 2019—Rules 6, 7 and 9 - Paul P.P. v. Union of India and others - I.L.R. 2025 Kerala OnLine 354: Neutral Citation No. 2025:KER:78570.

Kerala State Commission for Minorities Act, 2014 (Kerala Act 5 of 2014) —Sections 9 and 12—Jurisdiction—Scope and limits—The Minority Commission cannot entertain every grievance raised by a member of a minority community or grant relief in matters falling outside its statutory mandate—The Commission can exercise only such powers and functions as are expressly conferred upon it by the Act and cannot usurp or exercise powers that are vested by law in another statutory authority - State Environment Impact Assessment Authority and another v . Kerala State Minority Commission and another - I.L.R. 2025 Kerala OnLine 348 : Neutral Citation No.2025:KER:76516.

Negotiable Instruments Act, 1881 (Central Act 26 of 1881)—Sections 118, 138

and 139— Standard of proof which is required from the accused to rebut the statutory presumption under Sections 118 and 139 is preponderance of probabilities and that the accused is not required to prove his case beyond reasonable doubt—Test of proportionality should guide the construction and interpretation of the statutory presumptions and the accused cannot be expected to discharge an unduly high standard of proof - Koranil Yusuf v. Firoz V.A and another - I.L.R. 2025 Kerala OnLine 352: Neutral Citation No. 2025:KER:80508.

Registration of Marriages (Common) Rules, 2008 (Kerala)—Rule 11—A Muslim male cannot register his second marriage in accordance with the Rules, without notice to the first wife, when her marital relationship with him is in existence—However, if the second marriage occurs after pronouncing Talaq of the first wife, there is no necessity to give notice to her—Notice and opportunity of hearing must be given to the first wife before registration—Registrar cannot decide validity of the marriage but must refer the matter to a competent court, if objections are raised—Muslim Personal Law permits polygamy only in limited circumstances ensuring justice and fairness—Constitution of India—Articles 14 and 15 - Muhammed Shafeef C. and another v. State of Kerala and another - I.L.R. 2025 Kerala OnLine 351: Neutral Citation No. 2025:KER:82441.
