Wakf Act, 1995 (Central Act 55 of 1995)—Section 3 (r)—Creation of Wakf— There must be permanent dedication of the property—If the property being transferred with the intent of being treated as ‘Waqf’ has the facet of being alienated or being transferred to third parties by the donee (to whom the property is transferred), depending on his choice and discretion, then clearly it does not qualify as a ‘permanent dedication’ - State of Kerala v. Evidence Act, 1872 (Central Act 1 of 1872) — Section 13— Proving custom — Where a party relies on a customary right, evidence may be given of past transactions or instances showing that such a custom has been continuously and uniformly asserted or recognized in their community for a considerable period - Kizhakkayi Dasan v. Divorce Act, 1869 (Central Act 4 of 1869)—Section 10(1)(x)—Matrimonial Cruelty— Ill treatment of children by the wife amounts to mental cruelty to the husband, giving rise to a reasonable apprehension that it would be harmful or injurious for him to live with her—The nature of cruelty justifying dissolution of marriage must be uniform across all faiths—The law cannot recognise different standards of matrimonial cruelty based on religion - Emilda Varghese @ Rajani v.

Constitution of India—Article 226—Locus standi—Persons who are not directly affected by appointment of the Inquiry Commission are not entitled to challenge the appointment - State of Kerala v.
