Anatomy Act, 1957 (Kerala Act 17 of 1957)—Sections 4A and 5—Party in lawful possession of the body after the death having knowledge about the request made by the deceased person to provide his body for the purpose of medical studies, can report the fact to the authorised officer, unless the said party has reason to believe that the request was subsequently withdrawn—Factors to be verified by the authorised officer, enumerated—Statute does not contemplate resolution of any dispute in the matter of handing over the body, other than in Section 5 —Authorised officer has not been conferred with any authority to undertake dispute resolution or adjudication—Others' disputes will have no impact on request of deceased, especially when there is no claim as to a contrary wish expressed by the deceased—Reviewing factual conclusions made by the lower court, tribunal or authority, even if they are incorrect, are generally not within the contours of the Writ jurisdiction—Constitution of India—Article 226 - Asha Lawrence v. Constitution of India—Article 226—Scope of Judicial Review of Recommendation of

Co-operative Societies Act, 1969 (Kerala Act 21 of 1969)—Sections 66, 66A and 69—Any power bestowed upon Registrar under Rule 176, do not extend to employment related disputes once they fall within the statutory framework of Section 69—Supervisory powers conferred upon Registrar, is limited to pre-employment contexts, prior to establishing an employer-employee relationship—Service-related disputes within Co-operative societies must fall exclusively under arbitration jurisdiction under Section 69—Non-obstante clause in Section 69 would override powers granted under Rule 176—Supervisory powers granted under Sections 66 and 66A do not supersede or negate jurisdictional boundaries established in Section 69—Any dispute recognized under Section 69 cannot also simultaneously invoke Sections governing general directions or guidelines—Nature of power under Rule 176 examined—Co-operative Societies Rules, 1969 (Kerala)—Rule 176 - Joseph Mathew v. Direct Tax Vivad Se Vishwas Act, 2020 (Central Act 3 of 2020)—The Vivad Se Vishwas Act, 2020 does not contain any provision that prevents grant of interest on delayed refund - Satwashil Vasant Mane v. Electronic Video Linkage Rules for Courts (Kerala), 2021—Cross examination through Video conference—If there are valid reasons Court should permit cross examination of witness through Video Conference—While granting permission, court can insist that all requisite facilities should be available at the remote point and a competent Advocate, well-versed with the facts of the case, be present in the court for the entire duration of cross-examination—Code of Criminal Procedure, 1973 (Central Act 2 of 1974)—Section 273 - Alex C. Indian Police Service (Appointment by Promotion) Regulations, 1955—An officer's inclusion in the list for appointment to the Indian Police Service (IPS) by promotion, will be provisional if the state government withholds the integrity certificate, if there are ongoing departmental or criminal proceedings, or if there are any adverse factors that make the officer unfit for the role - xxxxxxx v. Motor Vehicles Act, 1988 (Central Act 59 of 1988)—Section 173—Power of appellate

court—A perusal of Order XLI Rule 33 CPC shows that there is no legal inhibition to consider contentions of a non appealing party or a party who failed to file a cross objection to do complete justice between the parties—Compensation payable to claimant can be enhanced in an appeal filed by Insured, without any appeal or cross objection by the claimant—Code of Civil Procedure, 1908 (Central Act 5 of 1908)—Order XLI Rule 33 - Mahadevan K. v. Panchayat Raj Act, 1994 (Kerala Act 13 of 1994)—Section 204—If a person is found to have an office or a place of employment within the Panchayat area, statutory fiction is attracted and he will be deemed to be exercising profession within the Village Panchayat area—Free services and charitable activities are not expressly or impliedly excluded from the purview of profession tax even if they do not embody a “business” in the strict sense of the term—Panchayat Raj (Profession Tax) Rules, 1996 (Kerala)—Rules 2 , 4 and 14 - Thumpamon Grama Panchayat v. Union of India - ILR 2025 Kerala OnLine 29 : [Neutral Citation No. 2024:KER:91931](#)

Precedents—Not only the judgment of a larger strength is binding on bench of smaller strength but the judgment of the bench of a co-equal strength is also binding on a Bench of judges of same strength—Doctrine of per incuriam - Joseph Mathew v.
